

Plato Township-Board of Trustees Meeting-----August 26, 2025

Meeting was called to order by Supervisor McMahon@ 6:00 PM

ROLL CALL-Supervisor McMahon, Trustee Myers, Trustee Hulke, Trustee Wallace, Trustee Wessel, and Clerk Straub- All present
Road Commissioner Trainor and Assessor Roush- Not present

Approval of the Minutes-

Trustee Hulke made a motion to approve the July Board Meeting minutes, seconded by Trustee Myers. The motion carried

Kane County Sheriff Report- No Sheriff representative was present to report, a power pole incident was discussed briefly, that occurred by entrance to Montague subdivision.

Supervisors Report-

- A. OMA and FOIA training was discussed and the need for an OMA Designee on the Board was presented. We will explore this further at the next meeting with the Trustees.
- B. The Cemetery Report was discussed on several topics. Making sure that the money in hand secures an appropriate interest rate when a CD comes due in September, as well as determining the legal/ true ownership of the cemetery properties for insurance and legal reasons is an ongoing priority that will be researched further. They are working on getting boxes of documents sorted and digitized at some point. The Cemetery Board is also still actively searching for another individual to fill the third Board member spot on their Board. Betty and Marty Rylco from the Cemetery Board attended the meeting with hand outs and Betty answered questions and presented some as well. Further investigation on all mentioned items is to follow.
- C. A meeting set up by the Kane County Board for September 8,2025 at the ECC Fire Training Academy-Burlington, Ill was discussed---,this to field challenges and wants of the Townships was mentioned by Supervisor McMahon . Further research into the configuration of the present KC Board and how it evolved from the early 70's was discussed and will be looked into further.
- D. An IMRF response letter was discussed, no response to it is needed at this time.
- E. 2 individuals from the Model Train Club made a presentation on setting up model train displays in the Park building— 1 Sunday afternoon a month- for free/demonstration. 3 hours They will be given a key to facilitate use of the Depot Building..
- F. The Forest Preserve property previously discussed and in question for being rented for crop production with no tax revenue apparent, was discussed. A letter from the County Assessor indicated that the Township will need to suggest specific parcels that they

- G. Fox Valley Dog Training Club has contacted the Township requesting permission to use an area in the Park as well.
- H. Supervisor McMahon went over the financials and answered questions. Total assets Township:-\$1,256,033.08—Total assets Road Fund-\$1,457,131.11.
